#### 1. About DARA and the Climate Vulnerability Monitor

DARA is an independent organisation committed to improving the quality and effectiveness of aid for vulnerable populations suffering from conflict, disasters and climate change.

In conjunction with the Climate Vulnerable Forum, a group of countries heavily affected by climate change adamant to amplify political pressure for a resolution to the climate crisis, DARA developed in 2010 the Climate Vulnerability Monitor. The Climate Vulnerability Monitor is a new tool built to assess the vulnerability of our world to the many effects of climate change as communities are facing them. It is developed with critical input from leading international thinkers and aims to help us keep watch on current and expected impacts caused by climate change and to promote understanding and debate around its growing dangers and how to deal with them.

## 2. Background

DARA is working towards the 2012 edition of the Climate Vulnerability Monitor, to be published in June 2012, a refined and expanded version of the volume published in December 2010. To fast-track and complement internal research and analysis DARA seeks to contract support capacity.

The research will build on the 2010 areas of analysis (health impacts, weather disasters, habitat loss and economic stress) at country level, by refining the methodology with updated data sources, new and improved indicators and more appropriate models. In addition, new sections on the causes of climate change and analysis on the funding mechanisms available to tackle the challenges posed by adaptation and mitigation needs will be incorporated to the study.

For this assignment, DARA is seeking a highly skilled, forward-thinking consultancy with an exceptional track-record working with climate vulnerability, application of socio-economic research and complex statistical models, and policy analysis.

#### 3. Tasks and deliverables

The following tasks will be required:

- Develop consultancy plan and time line in close collaboration with the head of the Climate Vulnerability Monitor and other DARA staff
- Work in collaboration with the head of the Climate Vulnerability Monitor, its peer review committee and other DARA partners
- Develop written briefing notes and end-product inputs on defined work streams
- Provide succinct briefings on the progress of work to the head of the Climate Vulnerability Initiative

The scope of the assignment will involve deliverables in three work streams. The responsibilities of the consultant are outlined below.

## Work stream A: Methodology and Approach.

#### 4. Requirements / competencies

- Knowledge of research initiatives and publications on climate vulnerability across the sectors addressed by the Climate Vulnerability Monitor: health, weather-related disasters, habitat loss and economic losses
- Excellent knowledge of socio-economic analysis, including public health, environmental economics, development economics
- Proficiency in socio-economic statistical methods
- Understanding of climate change negotiations, including climate risks, adaptation, financing
- Forward-thinking consultancy
- · Outstanding English oral and written communication and presentation skills

# 5. Activity duration

Expected duration of the assignment will be February to June, 2012, with time-critical inputs delivered to the deadlines indicated for each deliverable in section 3.

#### 6. Place of performance

Work performed over the duration of the contract will be undertaken mostly in consultancy's offices or as need be at DARA. Some international travel will be required.

- Technical proposal, including approach and time needed to complete tasks
- Resume CVs of proposed team
- · Itemized financial proposal
